## Our Focus on GME And CME Will Continue



The AOA House of Delegates meeting is behind us, but the work of achieving a successful definition and smooth implementation of the unified graduate medical education accreditation system remains ahead of us. The com-

mittees and positions that will accomplish this are in the process of appointment by the AOA, AACOM and the ACGME. We have encouraged our members to apply and will be submitting nominations where appropriate. We hope to get our most knowledgeable, effective representatives contributing at this vital time.

The resolution in support of the single accreditation system passed by the House of Delegates set the process in motion to include a focus on key issues such as recognition of our program directors' AOBIM certification, preservation of community-based programs and the promotion of osteopathic principles.

There are many questions unanswered. One of the central concerns is how many of our programs will actually choose to pursue an

# AOA Installs Robert S. Juhasz, DO, FACOI as President



**Robert S. Juhasz, DO, FACOI**, an AOA board-certified internist and Active Member of the ACOI, was inaugurated as the 118th President of the American Osteopathic Association (AOA), during the AOA's Annual Business Meetings in July. A former ACOI Board of Directors member, Dr. Juhasz is the fourth internist to lead the AOA in recent years, following **Eugene A. Oliveri, DO, Karen J. Nichols, DO** and **Larry A. Wickless, DO**.

Dr. Juhasz's inauguration was the culminating event of weeklong meetings that also saw the AOA House of Delegates endorse a plan to pursue a single accreditation system for graduate medical education. (See related story on

page four.) ACOI leaders actively participated in the meetings, providing input during the deliberations and hosting several events for internists in attendance.

## 2014 Convention Registration at Record Levels

Early sign-ups for the 2014 ACOI Annual Convention and Scientific Sessions are higher than for any previous convention at the same juncture, including the 2013 meeting, which set a record with 1358 attendees. The 2014 convention will take place October 15-19 at the Baltimore Waterfront Marriott Hotel in Baltimore's historic Inner Harbor. A full program of educational and networking events is planned. Up to 38 AOA 1A CME specialty credits are anticipated.

This year, the program will feature a full-day Fundamentals of Critical Care Support certificate course on Saturday, October 18. Separate registration is available for those who wish to register only for this course, which is designed by the Society of Critical Care Medicine. Seating is limited and at this writing only 30 spots remain.

## Physicians at Teaching Hospitals, Part II

Rules established by the Centers for Medicare and Medicaid Services (CMS) address the service and documentation requirements for several different patient care scenarios for Physicians at Teaching Hospitals (PATH). Key points are:

- At a minimum, documentation must identify the service furnished; participation of the teaching physician in providing the service; and whether the teaching physician was physically present;
- When billing for a minor procedure (less than five minutes to complete, for example, a simple suture) that involves relatively little decision-making, the teaching physician must be present for the entire procedure in order to bill for the service;
- For endoscopy procedures, the teaching physician must be present during the entire viewing-insertion to removal of the scope. The teaching physician viewing through a monitor in another room does not meet the requirements;
- Interpretation of a diagnostic radiology and other diagnostic test is payable only when performed by or reviewed with a teaching physician. If the teaching physician's signature is the only signature on the interpretation, Medicare assumes he or she personally performed the interpretation. If the only documentation is the countersignature of the teaching physician on the resident's interpretation without indication of review, Medicare will not allow payment.

Documentation of attendance as listed above and of review of reports are central for Teaching Physicians per Medicare guidelines (MCM, Chapter 12, Sec 100) and most carriers.

## Open Payments Database Taken Off-line

The Centers for Medicare and Medicaid Services (CMS) has announced a delay of a portion of the Open Payments program following efforts to investigate “a reported issue.” The Open Payments program was created by the ACA and requires applicable manufacturers of drugs, devices, biologicals or medical supplies to report annually certain payments or other transfers of value to physicians and teaching hospitals. As a result of the delay, physicians will not be able to review and dispute reported information about them until the issue is fixed. The required reporting is intended to promote transparency of financial relationships between the medical industry and healthcare providers on a publicly accessible website to help consumers make informed decisions.

According to CMS, “After an assessment of the data resulting from a complaint, we discovered that a limited number of physician payment records submitted by at least one manufacturer incorrectly contained information about other physicians.” While CMS has delayed the review and dispute stage of the program, it has not made clear whether it will delay the public launch of the website. Further, CMS has not indicated the expected duration of the delay. In a letter to CMS, the ACOI and others call for a delay in the program to address this and other issues. The ACOI will continue to closely monitor the situation.

## ACA Possibly on its Way Back to the Supreme Court

Two federal appeals courts recently disagreed on the interpretation of language contained in the Patient Protection and Affordable Care Act (ACA) providing for the payment of subsidies to low-income individuals who purchase coverage through Exchanges. Specifically, the question is whether subsidies can be provided to individuals who purchase coverage through federally-run Exchanges which were established in states where states refused to create their own. The law as written allows for the payment of subsidies when an Exchange is “established by the state.” The split decisions ensure that additional legal maneuvering will take place and creates the possibility that another issue created by the ACA will be reviewed by the Supreme Court. The competing decisions are significant in that they go to the heart of the ACA’s efforts to make available affordable healthcare coverage. The ACOI will continue to monitor these cases.

## VA Healthcare Legislation Signed into Law

Recent bipartisan efforts led to the approval and enactment of legislation aimed at reforming the delivery of healthcare services to veterans. The President signed into law a \$17 billion legislative package that creates 27 new Department of Veterans Affairs (VA) medical facilities; expands care for veterans at non-VA hospitals and clinics when they are unable to quickly receive an appointment or live far from other veterans medical facilities; and allows for the firing of senior executives. The law comes on the heels of revelations that veterans were not receiving healthcare services in a timely fashion at VA facilities across the country. An internal audit by the VA showed that more

than 120,000 veterans had not received a medical appointment, or were waiting more than 90 days for care at the time of the audit.

## Solvency of Medicare Trust Fund Extended

According to a new report released by the Medicare Trustees, the Medicare Hospital Insurance Trust Fund will have sufficient funds through 2030. This represents an increase of four years over the previous estimate released at this time last year. According to CMS, lower-than-expected spending in 2013 and lower-than-anticipated utilization rates have helped slow the growth of Medicare spending per beneficiary. According to the report, Medicare spent \$582.9 billion in 2013.

## Official Deadline for ICD-10 Implementation Set

CMS released a final rule establishing October 1, 2015 as the official compliance deadline for implementation of the International Classification of Diseases, 10th Edition Diagnosis and Procedure Codes (ICD-10). The deadline was first extended by Congress earlier this year and made official through the recently-released final rule. The deadline will not be delayed further absent additional congressional action.

## IOM Releases Highly Anticipated GME Report

The Institute of Medicine (IOM) released its long-awaited report examining the governance and financing of graduate medical education on July 29. The report entitled, “Graduate Medical Education that Meets the Nation’s Health Needs,” includes the following key recommendations:

- Maintain Medicare graduate medical education (GME) support at the current aggregate amount while taking essential steps to

# Message from President Greco On GME Accreditation

The following message from ACOI President Rick A. Greco, DO was emailed to all ACOI members following the action by the AOA House of Delegates last month to move forward with creating a single GME accreditation system:

Dear fellow ACOI members:

As many of you know, the AOA House of Delegates acted this weekend to reaffirm the decision to work toward a single GME accreditation system. The ACOI was well represented during the discussions, trying to assure that the concerns we have will be addressed.

You can read our full position statement on GME unification here: [www.acoi.org/NewsUnifiedGME.html](http://www.acoi.org/NewsUnifiedGME.html). In brief, we believe that AOBIM certification must be

recognized as an appropriate credential for our program directors, that provisions must be made to protect our smaller, community-based and rural training programs, and that residency positions must be available for all osteopathic college graduates.

I was privileged to be able to address the Board of Trustees and House of Delegates on these issues and I believe that our concerns were heard. The unification transition is expected to take five years, beginning in July, 2015. The final action approved by the House requires the Board to provide an annual report to the House on what progress is being made to address our specific concerns, and those of many others. There was a strong sense of commitment to the single GME system expressed by the House, but not at the expense of debasing osteopathic certification or the loss of quality training programs.

The ACOI team at the meetings - including President-elect Judy Lightfoot, D.O., Executive Director Brian Donadio and Deputy Executive Director Tim McNichol, JD - was very active in presenting our position both publicly and in private conversations. I believe that our testimony was instrumental in convincing the House to add the reporting requirement. We will continue to press for appropriate resolution of these matters as the discussions continue.

Dr. VanderRoest has spoken at ACOI's annual conventions and served as the College's pulmonary section education chair in the past.

**Ms. Ciconte:** Tell me why you have dedicated your time and talents to ACOI.

**Dr. VanderRoest:** I have been privileged to participate in the leadership of the College with leaders such as Drs. Schaller, Bulger, Morley, Wickless and dozens of others for whom I have the greatest respect. As a program director, I am proud of my role in guiding the education of students and residents to become DO internists. With the ACGME taking over accreditation, I am not certain what will happen to the specialty colleges. However, I am committed to do what I can to see that the College continues as an education organization training students, residents and DO internists.

**Ms. Ciconte:** There are other national organizations for osteopathic medicine, such as the AOA, and organizations for pulmonary and critical care medicine. Why do you continue to be so involved with ACOI?

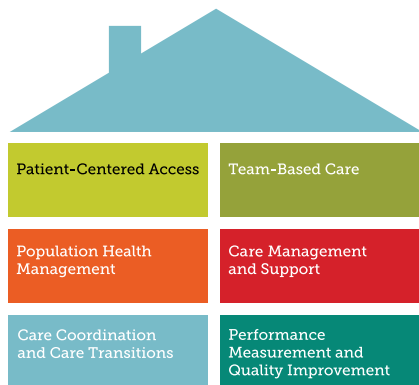

## Registration Now Open for NCQA Workshop on Patient-Centered Medical Home Recognition



The concept of the patient-centered medical home (PCMH) is receiving a great deal of attention as an important foundation for changing the way primary care services are delivered. Payers, purchasers and policymakers see the PCMH as a way to achieve improved access and patient experiences while increasing quality care and moderating costs.

To assist our members in preparing for the ever-changing health-care delivery system, the ACOI has teamed with the ACOFP and ACOP to offer a one-day workshop to provide the knowledge and tools needed to transform a practice into a PCMH and achieve National Committee for Quality Assurance (NCQA) recognition.

The workshop is being offered Saturday, September 13 from 8:00 AM to 5:15 PM at the Hilton Chicago O'Hare Airport in Chicago, IL. Participants will: get an overview of the NCQA recognition process; understand the increased emphasis on team-based care; practice PCMH scoring elements and develop documentation; and get a head start on PCMH recognition with the 2014 standards. modernize GME payment methods based on performance. The current Medicare GME payment system should be phased out.

- Build a GME policy and financing infrastructure that includes the creation of a GME Policy Council and a GME Center housed in the Department of Health and Human Services and CMS, respectively.
- Create one Medicare GME fund that includes an Operational Fund and a GME Transformational Fund.
- Modernize Medicare GME payment methodology.
- Mandate that Medicaid GME funding have the same level of transparency and accountability as Medicare GME funding.

Central to the report's recommendations is the need to reform the current GME system to better prepare physicians to practice in the ever-changing healthcare system. To this end, the report stated, "It is noteworthy that the accrediting bodies for both allopathic and osteopathic medicine--the Accreditation Council for Graduate Medical Education and the American Osteopathic Association, respectively--are currently remodeling their accreditation systems, in part to better care physicians for practice in the rapidly evolving US healthcare system."

The report goes on to acknowledge that while most training currently takes place in, and is sponsored by, large institutions, health care services are increasingly provided in ambulatory and community-based settings. As such, the report highlights the need to produce physicians more prepared to practice in settings where services will be needed in the future by expanding training at non-hospital sites. The report concludes by stating that Medicare support of GME should be continued on its demonstrated value and contribution to the Nation's health needs. ### Washington Tidbits:

#### O Say Can You See...History Awaits You in Baltimore

Washington, DC and its surrounding areas were under attack. The Nation was under siege and its survival in doubt. The War of 1812 was raging on and the British navy was flexing its might. A new battle was about to ensue. At stake was control of a vital port city and perhaps the future of a nation.

While working to secure the freedom of a citizen who was taken prisoner for allegedly violating his Oath of Good Behavior to the British, an attorney and colonel learned of an impending attack on Baltimore, MD. After successfully negotiating the release of the prisoner, the men were not permitted to return to Baltimore because of their knowledge of the military operation that was about to come. While confined to a small ship behind the invading British forces, they could only watch the rockets' red glare and bombs bursting in air. Amazingly, at first light the following morning, lawyer Francis Scott Key saw our flag still flying. He immediately penned what would become known as the Star-Spangled Banner.

and/or local- accredited education provider, allopathic or osteopathic, for all local and national requirements. The fragmentation of different rules for each state while appropriate years ago is no longer practical. I feel The CME accreditation issue is a critical issue to the ACOI and its members.

**Ms. Ciconte:** You have been a long-time supporter of the resident text book program and resident session at the ACOI annual convention. What motivates you to support these efforts?

**Dr. Miller:** I am proud of the people I have trained over the years. As mentioned, it was my residents who conceived the idea of the resident session and the ACOI supported this effort. It has since evolved into a major part of the Annual Convention and Scientific Sessions. My contributions demonstrate my commitment to the residents. As I mentioned earlier, it is important to support the people that support me. From Brian Donadio on down, the ACOI staff is there when you have a problem and it will be solved if possible to do so.

ACOI thanks Drs. VanderRoest and Miller for the many contributions they have made and continue to make to help the College educate and train the next generation of osteopathic internists.

Dr. Juhasz is president of the Cleveland Clinic's South Pointe Hospital in Warrensville, OH. He has served the ACOI and profession in many capacities, including terms on the Board of Directors from 2002-2008, as internal medicine residency program director at Brentwood Hospital (now South Pointe Hospital), and on numerous committees. He serves as associate dean of the Ohio University Heritage College of Osteopathic Medicine (OU-HCOM), Cleveland Clinic Extension Campus, and is an assistant clinical professor at the Cleveland Clinic's Lerner College of Medicine at Case Western Reserve University.

An early adopter of electronic health records, Dr. Juhasz was actively involved with the implementation of the electronic medical record system at the Cleveland Clinic. In 2005, he participated in a panel with President George W. Bush to discuss the benefits of electronic medical records and the president's goal to have all physicians participating in their use by 2014. Dr. Juhasz also serves as the AOA's liaison to the United States Preventive Services Task Force at the Agency for Healthcare Research and Quality.

# Healthcare Leadership & Management Program for Physicians – An Update



In 2012 the ACOI introduced the groundbreaking Healthcare Leadership and Management Certificate Program in conjunction with the University of Texas at Dallas, Naveen Jindal School of Management. The program is a non-degree certificate program delivered in an asynchronous online format that accommodates the busy professional and personal lives of practicing physicians.

The 10-month program is designed to address the needs of early to mid-career practicing physicians who want to acquire formal leadership and management knowledge and skills and gain new knowledge and insights that provide the tools needed to thrive in an environment where value creation is increasingly important for providers facing the challenges of risk-based reimbursement.

With two years of experience, the program has proven to be a valuable resource for personal learning advancement as measured by participant surveys and testimonials. A 2013 program graduate commented, “The amount of personal growth and professional development this course provided was unbelievable. It is not only worth the time and money, but developing relationships with other students I am sure will last quite a while.”

The course was developed to advance the principles outlined in the Phoenix Physician concept paper authored by ACOI leaders and published in 2012. The course is taught entirely online and is comprised of 11 units divided into the following three sections: interpersonal and communication skills; leading and managing in an interdependent world; and, providing value-based care for individuals and groups. The creation of value is central to the last five units, taking participants into the domains of population health management, clinical informatics, practice space improvement strategies and tactics, and team-based care delivery.

The course is made highly interactive with two progressive case studies. The Daily Clinic case study guides participants to the steps required to convert a traditional primary care practice into a Patient-Centered Medical Home. The Synergy Hospitalist Group case study takes participants through the challenges of merging multiple

providers into a single group while addressing impatient challenges hospitals often encounter. Participants post online responses to exercise questions that accompany each new chapter of a case. Responses are available for review and comment by fellow students and faculty, creating a lively virtual learning community.

The course takes approximately 10 months to complete. New units are introduced at three-week intervals allowing participants sufficient time to complete the sections and manage unexpected interruptions. Students in the program report spending an average of 10 hours per unit reviewing course video content, completing assigned readings, successfully completing the unit quiz, and replying to case study questions.

ACOI members have asked why they should consider enrolling in the course. The program includes a way for individuals or organizations to provide high potential physicians a solid introduction to leadership and management knowledge, skills and competencies. In addition, for those who find themselves contemplating or participating in risk-based reimbursement agreements, the program provides a working knowledge of patient population management and how to subdivide a practice panel into risk-stratified patient subsets. Finally, others have enrolled to prepare themselves for the rapidly-changing healthcare delivery system. One graduate commented, “This course has given me a solid foundation to embrace the upcoming changes and the ability to assess changes as they are made.”
