Residency Growth Continues As GME Transition Begins

The 2016 ACOI Survey of Internal Medicine Residency Programs was completed by DMEs and Program Directors of all osteopathic internal medicine programs for the new training year. There are now 146 approved internal medicine programs, with 117 training residents. That is 22 more programs approved and four more with trainees than last year. There are 690 first year residents, up from 625 last year. Perhaps for the last time, approved and filled positions both increased significantly this year. The total number of residents in internal medicine, including combined programs, is 1964 a 9% increase over last year. To put things in perspective, there were 541 filled positions in 2005-2006.

As part of the process of combining the AOA and ACGME accreditation processes, there were incentives for the creation of new programs prior to July 1 of this year. This resulted in the approval of 22 new programs. Approved positions increased from 2371 to 2965. Reportedly, 2880 of these are funded. Approximately 68% of the funded positions are filled, which is significantly lower than in recent years. This is likely attributable to the fact that many of the new programs were not approved in time to match with residents this year.

House and Senate Are in Session

The House and the Senate have returned from their August recess with a number of pressing issues that must be addressed before the end of September. One of the most pressing matters is the approval of appropriation legislation to keep the federal government open for business. Absent some form of compromise to either fund the government for the full fiscal year or for a shorter period of time while negotiations continue, it is possible that parts of the government will shut down. The current status of negotiations, the passing of each day and the current political environment is making it increasingly likely that there will be at least a partial shutdown. The ACOI is continuing to monitor this matter closely.

CBO Report Sees Growth in Medicare and Medicaid Spending

According to a report released by the non-partisan Congressional Budget Office (CBO), federal spending for all major healthcare programs will increase by \$106 billion in 2015. The largest increase in spending is expected to be seen in the Medicaid program. Medicaid spending is projected to increase by \$49 billion to a total of \$350 billion. The report cites the Affordable Care Act (ACA) as the primary driver of the increase in spending under the Medicaid program because of the resulting expansion of Medicaid recipients. Medicare spending is projected to increase by \$35 billion to a total of \$639 billion, the fastest growth in Medicare spending since 2009. The recently-enacted Medicare Access and CHIP Reauthorization Act (MACRA) is expected to result in additional growth in Medicare and Medicaid spending over the next decade.

Cardiologist Nominated to Lead FDA

President Obama nominated cardiologist Robert Califf, MD, to serve as Commissioner of the Food and Drug Administration (FDA). Dr. Califf is a researcher who joined the FDA in January of this year. He currently serves as the Deputy Commissioner for Medical Products and Tobacco. Dr. Califf has held this position since March. His nomination now goes to the Senate where it is expected to be approved with little dissent. The current acting Commissioner, Dr. Stephen Ostroff, took over following the resignation of Dr. Margaret A. Hamburg who served as Commissioner of the FDA for nearly six years.

ACA Headed Back to Court

The US District Court for the District of Columbia ruled that the House of Representatives can proceed in a lawsuit brought against the Obama administration. The House brought suit alleging that the Administration improperly used unappropriated funds to implement the ACA. The suit argues that the President spent billions of dollars absent any appropriations by Congress in violation of the Constitution. While the case was viewed by many to be political in nature, the court found, "It became clear that the House has suffered a concrete, particularized injury that gives it standing to sue." The ACOI will continue to monitor this case and its potential impact as it works its way through the judicial system.

HHS Awards nearly \$500 Million in ACA Funding to CHCs

The Department of Health and Human Services (HHS) announced nearly

\$500 million in grants awarded to community health centers (CHC) to increase access to primary care services and renovate facilities. Specifically, about \$350 million will be provided to 1,184 CHCs to increase access to services. Grants totaling nearly \$150 million will be provided to 160 CHCs to fund renovations, expansion or construction. According to a statement by HHS in announcing the grants, "These awards will give 1.4 million more Americans across every state access to comprehensive quality care." In total, CHCs serve nearly 23 million people in rural and poor urban areas at approximately 9,000 clinical sites in every state and US territory.

Presidential Debates...

Television's Impact on the Electorate

On a September evening the candidates entered the television studio to debate and share their vision for the future of the nation. Many would argue that the debate fundamentally changed the trajectory of the elections and ultimately the outcome of the race for the White House.

This time the stage did not consist of 17 candidates or even 10 candidates. It consisted of just two people vying to become the 35th President of the United States, Democratic nominee Senator John F. Kennedy and Republican nominee Vice-President Richard M. Nixon. The date was September 26, 1960 and it was the first televised presidential debate. Political scientist would agree that it became abundantly clear that preparation, stage presence and appearance would become critical factors in the new medium of televised politicking and impact the perceptions of the electorate. As the 2016 presidential campaign picks up steam and the debates get underway, what lessons will be learned for future presidential hopefuls?

ICD-10 Requires Communication with Staff

As I write this, the transition to the new International Classification of Diseases, 10th Edition, Diagnosis and Procedure Codes (ICD-10) implementation is set to begin October 1. As a consultant and educator, my life has been consumed as of late working to help physicians and practices get ready. Following is one final piece of advice prior to the transition.

Talk to your staff. Starting today and through the transition period, communicate with your staff. The interaction is invaluable for both the physician and the staff as you enter this new era of coding. Everything about successful ICD-10 coding begins with proper documentation. Your staff knows what to do with the documentation, which is essential in ensuring complete and accurate coding. What you "write" in a patient's record is crucial to selecting the specificity that ICD-10 requires. This information, mostly all clinical, can only come from you and it must be present. It is in your head. As the physician, you have the knowledge to treat the patient, you need to be sure to communicate the necessary information to others for the purpose of maximizing your compensation.

A successful transition to ICD-10 coding is in your hands. The information you document about a patient's condition is what will in the end ensure proper reimbursement for the services you provide.

Meet **David F. Hitzeman, DO, MACOI**, retired Professor of Medicine and Internal Medicine Program Director at Oklahoma State University College of Osteopathic Medicine. A former member of the ACOI's Board of Directors, he currently serves as a Member of the ACOI's Practice Management Committee, Chairman of the AOA Bureau of Socioeconomic Affairs and represents the AOA as a member of the AMA Resource Based Relative Value Update Committee (RUC). Dr. Hitzeman is a nationally known speaker on physician payment and participated in the College's Visiting Professor Program.

Ms. Ciconte: Tell me why you have dedicated your time and talents to ACOI.

Dr. Hitzeman: In my early years of practice, I saw firsthand the importance of involvement

in the "politics" of medicine at the hospital where I worked, the medical school, and with state and national medical organizations. It was only natural for me to become active at the national and federal levels by getting involved with the AOA and the ACOI, which was good for me as a physician and for my patients.

Serving on the ACOI Board of Directors was a wonderful experience due to the fact that the board worked well together, very much like a family. Together with ACOI's excellent staff, the Board was able to accomplish important common goals for the College. The ACOI Board continues to be a strong, dedicated group leading the College into the future.

Ms. Ciconte: How can ACOI continue to serve its members in the future?

Dr. Hitzeman: The ACOI needs to be bold in maintaining our distinctiveness as osteopathic physicians given the challenges associated with the single pathway for ACGME accreditation. In the past, due to an insufficient number of osteopathic training fellowships, many graduates chose to participate in an ACGME allopathic fellowship program but did not return to membership in the ACOI. I am pleased that in the past few years, the number of osteopathic training fellowships has increased. A recent AOA survey found that 70-75% of respondents wanted to continue their post-graduate training in an Osteopathic-focused Program. I feel that the osteopathic approach to patient care has now become the goal of policymakers and allopathic medicine. The phrase "patient-centered care," a popular buzz word today for the norm for patient care, is nothing new for osteopathic physicians. It has always been the hallmark of our patient care.

I believe the ACOI needs to look at these upcoming changes as opportunities. ACOI needs to think about where we want the College to be in 10 years. We should keep doing what we do best and continue to add new programs.

Ms. Ciconte: In addition to sharing your time and talents with ACOI, you are a donor and Charter member of the Legacy Society that honors those who include

the College in their will or estate plan. Tell me what motivated you to make a planned gift to the ACOI.

Dr. Hitzeman: I was on the ACOI Board when the College first promoted planned gifts. My wife and I took advantage of the services that the College offered and created our estate plan. We continue to work with a financial advisor that we met at that time. As a board member, I saw what the College would need in the future to maintain and grow. I saw making a planned gift to help secure ACOI's future as a way to give back to the profession in addition to my teaching, speaking, and committee involvement.

Ms. Ciconte: What can ACOI do to encourage other ACOI members to give annually and consider joining the Legacy Society?

Dr. Hitzeman: I believe that ACOI members first need to understand why the College needs additional financial support. In my experience raising funds for other organizations and institutions, personal relationships are critical to securing gifts. Being asked to support ACOI by a trusted colleague or friend is key to successful fundraising. The ACOI needs champions in various areas of the country who will go out and meet with members who can help the College.

As for encouraging members to join the Legacy Society, the ACOI needs to continue to offer pertinent information on estate planning that will help leaders, members, and their families best provide for themselves, their families, and the organizations and institutions they most care about.

Ms. Ciconte: Dr. Hitzeman, ACOI thanks you for the many contributions you have made and continue to make to help the College educate and train the next generation of osteopathic medicine internists and further advance the future of osteopathic internal medicine.

DUAL PROGRAMS – The survey captured data on whether the responding programs are also approved by the ACGME. Thirty programs reported dual approval. One new program was approved and one (Carilion Clinic) dropped its AOA accreditation this year. Dually-approved programs are training 317 residents (including combined EM/IM and IM/PEDS). That is 13 more residents than last year. Dual programs account for 21% of all programs, with 13% of all residents.

SUBSPECIALTY TRAINING – The number of osteopathic fellowship programs and positions filled also continues to grow. One-hundred-six programs are actively training fellows, up from 100 last year. The number of subspecialty programs increased to 148 (12 more than 2014-15) with 644 approved positions, an increase of 74. There are now 369 fellows training, which is up from 345 fellows last year.

LAST YEAR'S GRADUATES The ACOI's online Resident Annual Reports require graduating residents to report their future plans. For June 30, 2015 graduates, here are the results. Comparisons are to 2014 data:
